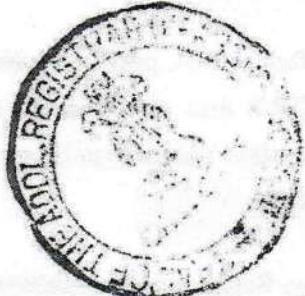

#### 4. OBJECTS

The principal object of the trust is to promote education. For the purpose of achieving the principal object, the trust shall have the following particular objects-

- v. The Settlers shall be trustee for life and would not be subject to retirement during their life time.
- vi. Trustee other than Settlers shall have office tenure of five years from the date of appointment subject to clause VIII here under.
- vii. Any casual vacancy caused due to death, incapacity or removal of any trustee, except the settlers, shall be filled within sixty days, in a meeting of the trustees, by majority voting, subject to ratification by the Settlers.
- viii. Any casual vacancy caused in the office of the trustee due to death or incapacity of the settlor/s, shall be filled only by the person/s nominated by the settlers while living, with due intimation to the trustees in writing or as per the testamentary will of the settlor. Where there is no nomination by the settlor to this effect and also no testamentary will, then 'by the remaining settlor only. However, if all the three circumstances cited hereinabove, are not fulfilled, then the casual vacancy caused in the office of the trustee, due to death/ incapacity of the settlor, shall be filled by the immediate family, i.e., Son/s, Daughter/s and daughter in law/s, with mutual consent only.
- ix. Except Settlers every other trustee shall be subject to compulsory retirement after a period of five years tenure in office from the date of appointment and will be\* eligible for reappointment or re-nomination only with mutual consent of both the settlers. The settlers shall with mutual consent, nominate new trustees in place of the retiring trustees at the end of every tenure.

- x. If any trustee wants to resign before the due date of automatic cessation of his office, due to any reason, may do so by serving notice of at least 60 (Sixty) days at the principal office of the Trust and sending an email to that effect to the settlors. On receipt of the notice, if settlors consider it fit, may call a meeting of the trustees to discuss the resignation and may be relieved from the duty, after ensuring that the resigning trustee/s do not owe any money to the trust. Pending relieve, the trustees powers shall stand suspended automatically on tendering the resignation.
- xi. If any trustee is believed to be acting against the interest of the trust, his powers and rights can be suspended immediately by the settlors, to be revoked only on being found non-guilty. For determining the involvement of any trustee in the antitrust activities, including financial fraud, embezzlement etc., and non financial yet activities which could have negative impact on the trust in any manner, the settlors could order an in house investigation or may take help of independent experts. However, where the trustee is found guilty of fraud and/or anti trust activities, on the basis of the investigation, he shall be removed immediately, by the settlors and would not require consent of any other trustee.

6. **RETIREMENT OF TRUSTEES**

On fulfilment of any of the following conditions a trustee shall retire from the trusteeship:-

- a) if he, without leave of absence, does not attend three consecutive meetings of the trustees or one calendar year, whichever is longer, or
- b) if he is requested to resign, by three fourth(3/4th) of the members present and voting or as near thereto as possible of the remaining trustees,
- c) on completion of the term for which he was appointed.

7. **MEETINGS, QUORUM AND RESOLUTIONS**

The Trustees may from time to time, frame rules for the conduct and regulations of the meeting of trustees. In the absence of such regulations:-

- a) Two Trustees shall form a quorum for a meeting of the Trustees.
- b) Resolution passed with consent of not less than two third (2/3rd) of the trustees shall be binding and effective.
- c) Resolution passed without any meeting of the trustees but by circulation thereof and evidence in writing under the hands of two thirds of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of trustees.
- d) One of the settlors or in his absence one of the trustees, duly authorised in writing, by both the settlors, shall act as the chairman of any meeting of the board of trustees. The chairman will have a casting vote in addition to normal voting right as a trustee. The casting voting right shall be exercised by the chairman, in case of tie in the result of voting.

**8. POWERS OF TRUSTEES**

That for the furtherance of the objects of the trust, the trustees shall have the following powers:

- a) to accept any donation, contribution, grant or subscription in cash or in kind, from any person (s), body of persons or trust, with or without conditions.

- e) to borrow or raise or secure payments of moneys and also to lend money either with or without security.
- f) to acquire any kind of movable and immovable Property in name of the trust, to be used exclusively for the objectives of the trust including letting out thereof. Property so acquired shall be part of the trust fund.
- g) to sell, dispose off, alienate or otherwise deal with any property comprising the Trust Fund.

11. **REGULATIONS RELATING TO ADVISORY COMMITTEE**

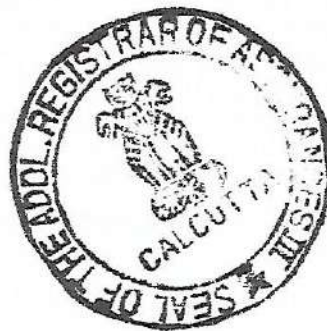
- 11.1 The trustees shall have power to appoint an Advisory Committee of not more than ten persons, which can be dissolved and reappointed from time to time as the Trustees may think fit. Chairman will preside over all the meetings of the Advisory Committee. In the absence of the chairman at any meeting, the members then present can nominate any one of them as the Chairman of that meeting. subscription as may be prescribed by the trustees from time to time. Such subscription will be treated as a donation to the trust fund.
